

Cherashore Playground Rebuild Project: Roof Evaluation Request For Proposals (RFP)

Project Description

The City of Philadelphia's Cherashore Playground complex serves the Olney neighborhood and is located at 851 W. Olney Avenue, Philadelphia, PA. The five-acre parcel includes a 2,600 sf single-story brick building, a pool, basketball courts, tennis courts, baseball and soccer fields, and playground equipment. The complex has been selected for improvement under the City's Rebuild initiative, with Mt. Airy Community Development Corporation as the selected Project User overseeing the work. The Scope of Work for this project includes both site and building renovations.

Services Requested

Existing Roof Evaluation and Survey

Description of Services

Mt. Airy CDC is seeking an evaluation of existing roof conditions for the Cherashore Playground Rebuild project. The recreation center was previously surveyed and contains an existing standing seam metal roof. The previous survey suggested that the roof underlayment contains asbestos. No documentation was included to verify that a test was completed to confirm the existence of asbestos on the building roof. Second, the existing roof includes internal gutters that are perennially clogged and remain a source of roof leaks throughout the building. As part of the renovation, Parks and Recreation would like to keep the existing roof in place if possible. Please evaluate and survey the existing roof and confirm no other water leaks are present. PPR would also like to replace the internal gutters with external gutters. Please confirm that no asbestos exists, confirm that the existing gutter can be removed, and confirm a new roof edge with external gutter can be installed without compromising the existing roof assembly to remain. Provide recommendations for detailing and installing warrantied roof construction that ties into the existing standing seam roof assembly.

Project Team

Mt Airy CDC serves as the Project Manager for the overall project. The selected applicant will coordinate and communicate with the project design team, including LAYER architects.

Responses to this RFP must be submitted as PDF files, size not to exceed 24MB. Applicants are reminded to be clear and concise in their responses.

Proposal Content

Qualification packages submitted in response to this RFP must include the following information, in the sections and order indicated:

- 1. Cover Letter of intent signed by a person authorized to issue proposals on behalf of the Applicant that addresses the following:
 - a. Why you are interested in being considered for this Project
 - b. Services / Disciplines your firm provides
- 2. Applicant Identification Info
 - a. Basic Information:
 - i. Firm name, address, website address
 - ii. Contact name, job title, email and telephone number
 - iii. Federal tax ID number or EIN
 - iv. Business status (i.e. corporation, partnership, LLC, for profit or not for profit, etc.)
 - v. Location of registration/license to complete work
 - vi. Country and state of business formation





- vii. Number of years in business
- viii. Significant business experience
- ix. MBE / WBE certifications
- x. Other information about Applicant's business organization pertinent to this RFP
- b. Include a brief history of the firm, including the overall firm organization and management structure, its goals and objectives.
- c. List and explain the circumstances and outcome of any litigation, arbitration, or claims filed against your company in the last 5 years.
- 3. Cost Proposal: Submit a cost estimate for your services.
- 4. Statement of Qualifications and Relevant Experience: Provide a statement of qualifications and a description of relevant experience.
- 5. Team Organization and Key Staff Resumes: The Applicant shall include a description of the proposed team. The description should clearly indicate the relationship of all key staff by depicting the technical roles/disciplines and responsibilities required for anticipated projects of this type.
- 6. References: (one page maximum) Provide at least two references, preferably for projects that are described in the Statement of Qualifications and Relevant Experience section above. If applicable, Applicant should provide references for projects with other municipalities that are similar in size to the City of Philadelphia. For each reference, include the name, title, organization name, address, telephone number and email address.
- 7. Applicant Declarations: The Applicant(s) must certify that they are able to meet the licensing, insurance, and administrative requirements to work on a Rebuild project, including the following:
 - a. Professional licenses and registrations (as applicable)
 - b. Certificate of Insurance
 - c. Financial capacity to perform the work
 - d. Ability to provide a City of Philadelphia Department of Revenue Tax Clearance Certificate and Commercial Activity License





e. Active listing in the Office of Economic Opportunity Registry or participation in the Emerging Vendor Program (if applicable)
